#### What's New in CLIP

##### **New Coding Rules**

Due to the release of the Eleventh Edition education material and answers to the frequently asked questions (FAQs) received up to 31 May 2019, Coding Rules will not be released on 15 June 2019.

In line with the implementation of Eleventh Edition, the retired Coding Rules list is also being released for implementation on 1 July 2019. Over 200 Coding Rules will be retired on or before 30 June 2019 due to inclusion or redundancy within Eleventh Edition, streamlining of answers to FAQs from previous editions and clinical updates. ### ICD-10-AM/ACHI/ACS Update

#### ICD-10-AM/ACHI/ACS Eleventh Edition

The following milestones have been achieved in this final quarter:

- launch of the online Eleventh Edition education (see update below)

- completion of the Reference to Changes document for ICD-10-AM/ACHI/ACS Eleventh Edition
- completion of the Chronicle for ICD-10-AM/ACHI/ACS, First to Eleventh Edition
- completion of ICD-10 to ICD-10-AM and ICD-10-AM to ICD-10 mapping tables for Eleventh Edition

### ICD-10-AM/ACHI/ACS future Editions

Following a strategic decision by the Independent Hospital Pricing Authority (IHPA), future ICD-10-AM/ACHI/ACS editions will be developed in-house by IHPA. Please refer to the IHPA website for their Work Program 2019-20. Therefore, from 1 July 2019 ACCD, led by the National Centre for Classification in Health (NCCH), University of Sydney with partners from Western Sydney University (WSU) will no longer be working on development and maintenance of ICD-10-AM/ACHI/ACS.

The NCCH is still a centre within the University of Sydney and will look to continue in the classification development and continuing education space in future projects, including its work with the World Health Organization Family of International Classifications (WHO-FIC) Network as part of the WHO-FIC Australian Collaborating Centre and its joint venture with the Health Information Management Association of Australia (HIMAA) in the organisation and delivery of the 2019 HIMAA and NCCH National Conference in Western Sydney between 23 to 25 October.

NCCH (as part of the ACCD) has been committed and has thoroughly enjoyed providing classification related services to the health care sector both nationally and internationally since 1994, and this year we celebrate 25 years in the classification development, education and implementation space. We would like to thank the members of the ICD Technical Group and all past advisory and technical group members that we have been associated with for their continued support and input into the Australian classifications. We would also like to acknowledge all our stakeholders including Health Information Managers and Clinical Coders that have contributed via public submissions and/or clinical coding queries which inform updates to the classifications as well as areas where education is required. We wish you all the best in the future.

Some slides and the exercise workbook have been revised and reloaded to the ACCD website. The updated modules are ACS 0002/0010, Obstetrics, Other ICD and Other ACHI.
